- 2. **Christine Woody** was introduced and welcomed as the new board member via unanimous vote 1st motion by Cynthia Sikaras, 2nd motion made by Cath Zurbach.
- **3.** The 2022.5.27 Meeting Minutes were approved unanimously, 1st motion made by Scott Davidson and 2nd motion made by Cathy Zurbach. Unanimously approved.
- 4. Q&A on Reports (Please read in advance)
 - i. President's Report: Discussed ensuring that the Borough and the Township are getting these updates via our liaisons. Sandra will send email both Mark and Marsha the monthly newsletter updates
 - ii. Treasurer's Report Bernadette Daniel shared that we are about \$500 over budget, but in actuality will be about \$12k under budget once the Media Borough funding hits
 - iii. Director's Report Sandra Samuel highlighted the Fine Free initiative. The Board voted via email unanimously to go fine free. Discussion on when to launch. Settled on after the new Strategic Plan is put in place. Sandra will work on messaging; share ideas on wording with her. Need to work on the Appeal Letter to go out in September 2022 via mass mailing and the newsletter email list and the Basic Funder email list which will be managed by the committee.
 - iv. Fundraising and Donor Relations Report Cynthia Sikaras briefed the highlights of the report, to include promoting the Jute bag. Media Borough is voting to get rid of plastic bags so the Jute bag may be able to be cross-promoted.
 - v. Governance Report Tu Packard briefed the highlights of the Survey. Christine will take the survey with fresh eyes. The committee will include Christine's feedback and then send out the survey. Discussion around how to get the survey out to patrons add to the Outreach list. Suggest that the Board read the 2017 Strategic Plan. Survey and Focus groups to wrap up in September. Strategic Plan to be finalized in December 2022. Tu reported that additional materials were added to the Welcome Kit folder that other board members may find useful. They include a Board Self-Assessment and Leadership by Design handouts, as well as Resources for Board Members. Tu said for her these handouts helped to clarify her duties and responsibilities as a library board member.
